As leadership quality is an essential part of the awards criteria for our scholarships, the China Oxford Scholarship Fund is pleased to inform friends and supporters that two Scholars have been chosen to participate in the Oxford Global Leadership Initiative's 2016-2017 programme. Scholars Hanyang Ye and Xian Guan will be 2 of 14 postgraduate students at the University of Oxford to take part in this exciting initiative organised by The Oxford Character Project. Hanyang and Xian will be part of a global leadership learning community and will be involved in a select group which will have the benefit of a tailored programme of discussions, guest dinners, and personal mentoring from senior leaders in their vocational field. Hanyang was a 2015 China Oxford Award recipient. He is currently a 2nd year DPhil student studying in Condensed Matter Physics and is at St Hugh's College. Xian is this year's Hoare Family Award recipient. She is studying for an MSc in Social Policy and is at St Antony's College. They will be following in the footsteps of Scholar Yuge Ma who was chosen as one of 13 graduate students at Oxford to take part in the inaugural cohort of the Oxford Global Leadership Initiative in 2014. Yuge was a China Oxford awardee in 2010 and a Wolfson China Scholar in 2011. Yuge earned her DPhil in Geography and the Environment and was at Wolfson College.

Q&A with Edward Brooks - Head of the Oxford Global Leadership Initiative

What is the main motivation for setting up the Oxford Global Leaders Initiative?

Over the centuries the University of Oxford has produced thinkers and leaders who have held positions of responsibility around the world, and this continues to be the case today. The ten thousand students studying for postgraduate degrees at Oxford are the elites of more than 120 nations, and they can be expected to go on to careers of great influence. It is also true, however, that these students will take up positions of responsibility at a time of significant global uncertainty, when there is a marked lack of confidence in leadership worldwide. How can Oxford students be prepared to contribute positively in this global context, learning to think in a way that is not only clever but wise, learning to lead in a way that not only furthers personal ambition but actively seeks the wider good of society? This was the question that engaged a group of senior Oxford academics in extended discussion some three years ago. They came to the conclusion that this kind of preparation for leadership wasn't naturally met through post-graduate programmes of study, so, with the generous support of the Templeton World Charity Foundation, the Oxford Global Leadership (GLI) was established.

How is this different from other leadership programmes at Oxford and other institutions?

Our distinctive focus is on the relationship between *leadership* and *character*, highlighting the centrality of personal character for the exercise of leadership that serves the common good. This stands the GLI apart from the majority of leadership programmes that focus on management strategy or practical skills. There is no doubt that strategies and skills are important, but

it is increasingly evident that these cannot guarantee good leadership, nor can supplementary leadership modules on ethics. Our approach seeks to understand leadership as a personal category before it is a professional one, placing values and virtues at the heart of good leadership.

Oxford graduates come from various parts of the world where "leadership" might have a different connotation. Is this taken into consideration when reviewing applicants?

Absolutely! In fact the different understandings of life and leadership that students bring with them—based on their nationality, academic background, or life experience—are central to our work, which seeks to prepare students for leadership in a globalised world. Rather than minimising these differences to impose a model of leadership, the aim of our 'learning community' is to hold an open discussion where students can share their various perspectives and come to an understanding of what good leadership will mean in a diverse yet interconnected world.

What do you look for in successful candidates?

It is a privilege to work amongst the gifted and motivated community of Oxford postgraduates, and it can almost be taken for granted that these students will make important contributions through their careers in the years ahead. In seeking to focus our work on a small group of postgraduates we look for two things: students who will engage reflectively and positively with others, and a diverse group in order to further our aim of learning from global perspectives for leadership in a globalised world. The current learning community is made up of 14 students from 10 nationalities and 11 different Oxford degree programmes, from cyber security, to neuroscience, to Islamic history and political theory.

What is the main challenge in your selection process?

The number of excellent applicants. Over the last three years, we could have filled each GLI cohort five times over with excellent students.

Why is the number of participants kept at a relatively small number?

Part of the answer is that the GLI is a new initiative just coming to the end of its pilot phase. We would love to include more students in the years ahead. However, we are also eager to keep working with small groups of students, enabling them to engage in deep discussions with others from different perspectives and talk personally with an incredible group of guest speakers and mentors, offering what we hope is a transformative experience.

What is the short-term and long-term goal for the Initiative?

Our immediate aim for this academic year is to invest in another excellent group of students including two COSF scholars, Xian Guan and Hanyang Ye. Beyond this year we are eager to be able to offer similar opportunities to a larger number of Oxford postgraduates and are actively seeking partners who might be interested to invest with us both in developing a new generation of leaders here in Oxford, and also in taking up invitations to establish partner projects at other leading universities worldwide.
